AGREEMENT

Rivers Edge and Owner/Agent named agree as follows:

Section One - General Terms

Rivers Edge, having received at the time and place shown herein the described pet for the purpose of boarding and any other service now or hereafter to be ordered by Owner, at the expense of and for the account of Owner, owner agrees to pay Rivers Edge the established rates for said services. Owner specifically agrees to be bound by the terms and conditions of this agreement.

Section Two - Liability

Rivers Edge shall not be liable for - and Owner hereby releases, discharges and acquits Rivers Edge, its agents or servants or otherwise any damages to the pet arising out of or from the Boarding/Grooming/Daycare of the pet or that accrue from any cause whatsoever therewith, including loss but not limited to, fire, theft, running away, death, illness, injury of any nature during the term of this agreement, whether the pet be on Rivers Edge premises or not. Owner shall be solely responsible for all acts and behavior of the animal at any time during the term of this agreement, and in no case shall Rivers Edge be liable for the pet's acts or behavior. Owner shall indemnify Rivers Edge against all damages sustained or suffered by reason of Boarding/Grooming/Daycare of the pet, for any claims or injuries whatsoever.

Section Three - Illness of Pet

In the event the pet becomes ill or injured while in the care of Rivers Edge, Owner hereby authorizes Rivers Edge, at its sole discretion, to contact a veterinarian of its choosing and obtain all treatment and attention as the pet requires. All transportation, veterinary care and hospitalization provided shall be at the sole expense of the Owner.

Section Four - Method of Payment

An advance deposit may be requested and final payment is to be made upon release of pet. If any pet is unclaimed or charges remain unpaid for a period of 10 days, Rivers Edge shall have complete authority to dispose of said pet by sale or otherwise, and to apply any proceeds toward such unpaid charges.

Section Five - Removal of Pet

Rivers Edge shall also have the right to request removal of said pet at any time and if such removal not made promptly, Rivers Edge shall have the same aforesaid authority to dispose of pet.

Section Six - Governing Law

Any disputes concerning the Boarding/Grooming/Daycare of the pet or the construction or effect of this agreement shall be governed by the laws of the State of Florida. If litigation occurs between the parties as a result of this contract, the prevailing party shall be entitled to recover attorney's fees incurred and all court costs. By the Owner/Agent signing below, and Rivers Edge accepting the pet, the parties agree to the above terms and conditions.
